**ORDER FOR ATTORNEY’S FEES AND SANCTIONS ON PLAINTIFFS’ MOTION
FOR SANCTIONS FOR FALSE PLEADINGS,
GROUNDLESS REMOVAL, AND BAD FAITH DISRUPTION OF TRIAL**

On this day, the Court considered Plaintiffs’ request for Attorney’s Fees and Sanctions on their Motion for Sanctions for False Pleadings, Groundless Removal, and Bad Faith Disruption of Trial. A hearing was held on April 6, 2023. After considering the pleadings, the record, the evidence, and the arguments of counsel, the Court finds that the motion is GRANTED in part and DENIED in part.

IT IS ORDERED that Plaintiffs are not awarded reasonable and necessary fees incurred for the April trial setting preparation.

IT IS ORDERED that Plaintiffs are awarded reasonable and necessary fees incurred in the bankruptcy courts relating to InfoWars, LLC in the amount of **\$63,110.00** plus court costs in the amount of **\$103.22** to be paid by attorney F. Andino Reynal.

IT IS ORDERED that Plaintiffs are awarded the non-refundable fees for accommodations made for the April trial setting in the amount of **\$8,956.07** to be paid by F. Andino Reynal.

IT IS FURTHER ORDERED that sanctions against attorney F. Andino Reynal pursuant to Tex. R. Civ. P. 13, Tex. R. Civ. P. 215, and the Court’s inherent powers in the amount of **\$25,000.00**


IT IS ORDERED that Plaintiffs should be awarded the following amounts should an appeal of the Court's ruling be undertaken:

1. In the event of an appeal to the Court of Appeals requiring a briefing, an additional \$44,000.00;
2. In the event of oral argument in the Court of Appeals, an additional \$11,000.00;
3. In the event of a Petition for Review to the Texas Supreme Court, an additional \$25,850.00;
4. In the event of a merits briefing in the Texas Supreme Court, an additional \$20,350.00;
and
5. In the event of oral argument in the Texas Supreme Court, an additional \$15,400.00.

IT IS FURTHER ORDERED that the payment of all amounts awarded under this Order must be made by attorney F. Andino Reynal within 30 days of the signing of this Order to Plaintiff's counsel of record.

All other relief requested by any party not granted herein is DENIED.
